Meeting Notes

Thoughts on fundraising as expenses taking funds too low

- MB Small amounts from forum members via website/internet appeal. Use ward budget if necessary. FD to investigate.
- JJ What is the money for? LH: stationery, website, target £3.5k.
- LH & JT seeing new ward Cllrs next week on Plan for breakfast. Separate meeting for CIL.
- JL MB to educate Cllrs on Soho Plan/to attend.
- LH Any others welcome.
- JT will be discussing Vision for Soho vs Plan.
- JL Waste is now on Cllr. Hug's desk. MB & LH to meet in due course. Circulated to ward Cllrs & Cllr Dimoldenberg
- JL Air quality monitoring can now be set. Pilots: Marshall Street, Broadwick Street, later also the school. Want 19 lampposts with fibre. Conway & WCC not responded. JT to send email to JM with alternative officer name.
- TL Parish gate architect says it may be easier to repair, considering. In play...



Toilets

- LH the Orbital proposal is comprehensive £38k, bigger job than refuse study.
- MB Is in Labour manifesto. Suggests taking it to Cllr Hug or Dimoldenberg.
- JT Talk to Soho Society about it to get Cllrs to take notice.
- TL Is the decision to park the fee proposal and to try to get WCC to pick it up? Was agreed.
- There was a discussion about where the problems are, who does the deed etc.

Community use and open spaces

- ND Met Tom Johnson of Diageo who are very keen to get involved locally; met ward cllrs recommunity space.
- PP met Adam Scott SS's colleague at House of St. Barnabas regarding a children's playground in Soho Square established that the problem might be London Squares Act.
- LH greening the designer was talking to Head of Parks re Golden Square. Need design to be costed. Not there yet.

CIL spending and governance

- Placemaking London Dan T and Catherine Jenkins created spreadsheet of Go/No Go type scoring system to make consistent discussions.
- JT regarding localised CIL funding, thinks WCC will move to Camden definition & be more flexible on what can fund.
- LH Please circulate the draft. Comments to LH; needs some members to help edit and test for final roll-out.
- Discussion on how the schedule treats tendering rather than tendered projects.
- LH Have done work on waste, on governance. Should we share with other forums?
- JM Wait until we have met new WCC Cllrs.
- Catherine have graphic flow diagram for website to show how a project may be selected.
- JM Must put governance on website.
- LH Not sending MB's note around forum.
- JT is leaving. He will introduce his colleague Dee Coursey at next meeting. The steering group needs a vice chair from businesses. Nomination by end of May.
- LH & TL want NWEC to remain on the group.
- MB BD, MB, business community need to input issues that are on the horizon, for all to understand. This should somehow be captured on the quarterly agenda.
- MS Drive to net zero, want to see how new admin at WCC picks up. City charters and what does this mean?
- TL How does net zero play out in your existing estate?
- MS Legislation on EPCs coming forwards: looking at retrofit as necessary in cases to even lease a building under this. Happily Shaftesbury tend to keep existing buildings' embodied carbon.
- TL What about footfall, trends, new land uses coming forwards?
- MB Will take question away.
- Catherine Jenkins WCC is resourcing up its carbon officers.
- JT WCC was looking at waiving rates for community uses.
- PP Why is Berwick Street development empty?
- MS it will be good quality, but is not personally privy to the letting strategy.
- House of St. Barnabas to look at whether they can host next meeting and goodbye drinks for JT.
